

**WINDY CITY-FOX MOTORSPORTS, LLC
RELEASE, LIABILITY WAIVER, AND HOLD HARMLESS AGREEMENT**

This Release, Liability Waiver, and Hold Harmless Agreement (the "Agreement") must be read and signed by all persons operating or riding on a motorcycle or otherwise participating in any event (the "Event") sponsored by Windy City-Fox Motorsports, LLC and/or any of its subsidiaries or current and future affiliates, including, but not limited to Windy City Motorcycle Company, LLC, Fox WC Holdings, LLC, Wild Fire Harley-Davidson, City Limits Harley-Davidson, Fox River Harley-Davidson, Illinois Harley-Davidson, Starved Rock Harley-Davidson, Barbed Wire Harley-Davidson, Milwaukee Harley-Davidson, Woodstock Harley-Davidson, West Bend Harley-Davidson, Lake Geneva Harley-Davidson, Chicago Harley-Davidson, Lake Shore Harley-Davidson, Woodstock Triumph, Woodstock KTM, Windy City Triumph, Wrigleyville Harley-Davidson, and Windy-City International Motorcycles (collectively "WC-Fox"). This Agreement will apply to all Events that occur during the 2021 calendar year. In consideration of my participation in any Event, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby agree as follows:

1. I represent that i) I am at least 18 years of age, ii) I have a valid Illinois driver's license, if operating a motorcycle during any Event and iii) I have valid automobile/motorcycle insurance.

2. I certify that I do not have any mental, physical, or other condition or disability that would impair my ability to operate a motorcycle. I further certify that I will not consume any alcoholic beverages, illegal substances, medications or any other drug or substance that may impair in any way my ability to safely operate a motorcycle during any Event.

3. I give permission irrevocably and in perpetuity to WC-Fox and its subsidiaries and affiliates to, without additional compensation to me, use, adapt, reproduce, distribute, display and publicly perform my name and visual likeness in whole or in part, worldwide, in connection with the promotional or marketing activities of WC-Fox and/or its subsidiaries or affiliates.

4. I ACKNOWLEDGE THAT MY PARTICIPATION IN ANY EVENT AND/OR OPERATION OF OR RIDING IN A MOTORCYCLE IS SOLELY AT MY OWN RISK AND I VOLUNTARILY ASSUME ANY AND ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN ANY SUCH EVENT. I AM AWARE OF THE HAZARDS, DANGERS, AND RISKS TO MYSELF AND OTHERS ASSOCIATED WITH OPERATING OR RIDING IN MOTORCYCLES AND ACKNOWLEDGE THAT IT IS MY CHOICE AS TO WHETHER OR NOT I WEAR A HELMET AND/OR ANY OTHER PROTECTIVE GEAR DURING SUCH EVENT. THEREFORE, I, ON BEHALF OF MYSELF AND MY SUCCESSORS, ASSIGNS, HEIRS, AND ESTATE (COLLECTIVELY, "SUCCESSORS"), HEREBY UNCONDITIONALLY AND FOREVER RELEASE, DISCHARGE AND AGREE TO HOLD HARMLESS WC-FOX AND ITS AFFILIATES AND SUBSIDIARIES, ALONG WITH EACH OF THEIR MEMBERS, MANAGERS, OFFICERS, DIRECTORS, EMPLOYEES, AGENTS AND CONTRACTORS (COLLECTIVELY, "RELEASED PARTIES"), FROM ANY AND ALL CLAIMS, ACTIONS, DEMANDS, JUDGMENTS, COSTS, DAMAGES, LOSSES, EXPENSES AND LIABILITIES OF EVERY KIND AND NATURE WHATSOEVER RELATING TO ANY CLAIM I MAY NOW OR HEREAFTER HAVE WITH RESPECT TO ANY DEATH, PERSONAL INJURY, PROPERTY DAMAGE, PECUNIARY LOSS AND/OR OTHER LOSS, DAMAGE, COST OR EXPENSE THAT MAY BE SUFFERED BY ME OR ANY THIRD PARTY AS A RESULT OF a) MY OPERATION OF AND/OR RIDING IN A MOTORCYCLE, b) ANY USE BY WC-FOX AND/OR ITS SUBSIDIARIES OR AFFILIATES OF MY NAME OR VISUAL LIKENESS, c) MY ATTENDANCE OF THE EVENT, OR d) ANY OTHER ACTION OR INACTION BY ME IN CONNECTION WITH MY PARTICIPATION IN ANY EVENT.

5. If any provision of this Agreement is found to be unenforceable in any respect by a court, it is my intention and understanding that this Agreement shall nonetheless be enforced to the maximum extent to which it is found by the court to be legally enforceable, and a finding of invalidity, illegality or unenforceability of one or more provisions of this Agreement shall not affect the validity or enforceability any other provision hereof.

6. This agreement shall be governed by the laws of the State of Illinois, without reference to its choice of law rules. I irrevocably consent to the exclusive jurisdiction and venue of the federal and state courts located in Du Page County, Illinois with respect to any claim or suit arising out of or in connection with this Agreement or my participation in this Event and/or the operation of or riding in the Vehicles, and agree not to commence or prosecute any such claim or suit other than in the aforementioned courts.

7. This Agreement constitutes the entire agreement between myself and WC-Fox with respect to the matters described herein, and supersedes any and all other agreements and communications, oral or written, between myself and WC-Fox or any other Released Party with respect to such matters. This Agreement may not be amended or supplemented except by a writing signed by WC-Fox specifically referencing this Agreement.

8. I acknowledge that I have read and fully understand the foregoing terms and am not relying on any statements or representations of anyone released hereby. I acknowledge that I am voluntarily operating or riding in a motorcycle and otherwise participating in any one (1) or more Events and I assume complete responsibility for all risks, tickets, injuries, death and/or property damage that may occur as a result of those risks, even if such tickets, injuries, death or property damage occur in a manner that is not foreseeable at the time I sign this release.
